Roundtable 1: Culture of collaboration and unconventional partnerships

Where do CHIEF Executive Forum members see more opportunities to increase collaboration for better results? By joining resources and expertise through a PPP, public and private stakeholders can reduce costs/burden, share risk, as well as gains, and help each other capture greater value. Dr. Tajirian was instrumental in helping CAMH achieve both HIMSS stage 6 and 7, and most recently the prestigious HIMSS Enterprise Davies Award. In addition to the Physician Engagement Strategy, Dr. Tajirian also leads the Hospital Medicine Division (~45 physicians) and is part of numerous organizational steering committees including chairing the monthly physician think tanks. She is also a physician wellness liaison and strives to celebrate excellence and foster a culture of wellbeing within CAMH. Most recently, in 2021, she was awarded the HIMSS Most Influential Women in Health IT Award.
