

### Who is OCINet?




OCINet is a not-for-profit corporation formed as directed by Ontario Health in 2022

OH directed the consolidation of the 3 legacy DIR operations into a single not-for-profit entity

Consolidates people, operations, and infrastructure into a singular provincial service.

## **A**pril 1, 2022


The three DIR programs started operating under one budget, one board of directors, and one organization as Ontario Clinical Imaging Network (OCINet).



OCINet is the culmination of over a decade of work, leading to one image-sharing mechanism for the entire province.







# **Consolidation - a key driver of the Imaging Strategy**

The Strategy proposes an investment roadmap to:



Achieve a single view of all clinical imaging from all care settings to improve care, reduce patient transfers, generate value, and enable advanced clinical analytics; and offer solutions for consolidating current Digital Image Repositories (DIRs)/Picture Archiving & Communications (PACS) technologies, adopting new and innovative image exchange technologies to achieve scale and provide a foundation for other digital image and report types.
